## ARTICLES OF INCORPORATION



### FARTHEST NORTH UNIT 426

#### ARTICLE 1 - NAME

The Corporation's name is **Farthest North Unit 426**.

#### ARTICLE 2 - PURPOSES, POWERS, ACTIVITIES

The Corporation's principal purpose is to serve as a unit of the American Contract Bridge League (ACBL). The Corporation will have all powers that a nonprofit corporation may have under Alaska law, including the specific powers enumerated in AS 10.20.011. The Corporation may engage in any activity that is not inconsistent with the Corporation's role as a unit of the ACBL or, if applicable, with the Corporation's status as a tax-exempt organization.

#### ARTICLE 3 - DURATION

The Corporation's duration is perpetual.

#### ARTICLE 4 - DIRECTORS

The Corporation will have at least three (3) directors and may have any greater number of directors. The number of directors will be set by, and may be changed by, the Corporation's Bylaws. The Corporation's initial directors are:

If the Corporation is dissolved, the Corporation's assets remaining after payment of the Corporation's debts and satisfaction of the Corporation's other obligations will be distributed to a qualified organization in accordance with the rules, regulations, or other standards of the American Contract Bridge League (ACBL).




